**LO:** So I have the order against uhh...I have an order against two men in Arizona and one in California and they were all umm...together and kinda coordinated...ummm...uhh...it's kind of complicated. Uhh do you want the mens' names?

**SP:** Uhh..yeah if I could get them.

**LO:** Yeah absolutely, so it's uhh...the first one is Greg Gillespie. Gregory Gillespie.

**SP:** How do you spell the last name?

**LO:** G-I-L-L-E-S-P-I-E

**SP:** Do you have his date of birth by chance?

**LO:** Umm...let me see. I have the order so I'm guessing that has it on it...ummm...[Redacted]

**SP:** Alright. And the second subject?

**LO:** Clayton. And the last name is E-C-H-A-R-D.

**SP:** Do you have that date of birth?

**LO:** Uhh...[redacted]

**SP:** And they are order of protections that you have against them?

**LO:** Uhh...yes. I have orders of protections against those two.

**SP:** Okay. Alright, Laura what I'm going to do is have an officer give you a call to talk to you [cut off by Laura talking]

**LO:** Oh...and and then there is one more.

**SP:** Oh there's one more?

**LO:** There's there's one more. I'm sorry about that. The other one is actually...yeah it's a California order. I-I got the order in California and moved to Arizona. But uhh I was told by San Francisco Police to contact you guys.

**SP:** Mmmhm.

**LO:** Umm...so that uhh man's name is Michael. And then I can spell the last name. It's M-A-R-R-A-C-C-I-N-I.

**SP:** And what's Michaels' date of birth?

**LO:** Uhhh...[Redacted]

**SP:** Okay. Okay. What I'm going to do is have an officer, like I said, give you a call to talk to you about making a report. It may show up as a blocked or restricted number when they call you so just for the time-being make sure you answer any phone calls you receive until you hear from us. Okay?
