Umm they also have...have been stalking me on...on social media and umm and I've tried to remain anonymous throughout this whole process and they just keep repeatedly saying my full name umm and they're...they're just literally out to ruin me.

I mean, it's obsessive. Like hundreds of posts about me.

SP: Okay. I just...I'll put in a call and have an officer give you a call back. Did you report the umm break-in to Phoenix PD?

LO: Umm no. Nope, I couldn't find...like there wasn't anything that looked like it was damaged or anything. It was just that I got the alert umm that..that somebody had, you know, opened the door.

SP: Okay. Alright. I'll have somebody give you a call back, okay?

LO: Okay, yeah, they...like the last thing they put like 5 minutes ago is 'she just needs to go away. Like, I mean and I'm not commenting on any of these things. It's just that, you know, they're just obsessed. So yeah, I would... would appreciate it. Thank you so much.

FBI: Umm...I...do not. Umm...it seems like she has a history of making reports to the Scottsdale Police Department from what I have found.

SP: Any mentions of any weapons or anything that she could have? Or are you aware of any?

FBI: No

SP: When did you guys receive this tip?

FBI: So we received this tip...give me a second and I'll tell you the exact time and date. So it was today, 12/4 at 10:50am.

SP: Okay. You guys are like 3 hours ahead or 2?

FBI: Uhh...yeah. We're on the east coast. Yeah I'm in West Virginia. So it looks like based on research that I have done umm through *[[Index??]]* it looks like on 11/7, it says Scottsdale PD did a welfare check on her previously for suicidal comments as well.

LO: Hi Courtney! My name is Laura Owens. I'm calling because I'm getting umm..I've been getting calls the last two days umm from somebody whose umm.. saying they're anonymous and they're harassing me and really creepy messages but I have TrackCall and I have their phone number.

SP: What have they said to you?

LO: Umm...they said like uhh...that don't try to figure out who called, they called me the c-word on there, umm...they said that they uhh..they keep telling me I need help, umm...that I'm toxic. That they uh...err...they are making fun of me ummm because I have two restraining orders against men. Ummm...they say that they hope I'm charged...
