IT IS HEREBY ORDERED granting Respondent's *Motion to Compel*.

IT IS HEREBY ORDERED compelling Petitioner to provide Respondent with the following disclosure:


1. All non-privileged records and communications related to the 2014 paternity matter involving Petitioner and [REDACTED] in California.
2. All medical records for Petitioner from Planned Parenthood Mission Viejo from on or about July 7, 2023.

- 1 3. The name and contact information for the medical abortion pill provider who
2 informed Petitioner she was pregnant with male and female twins and any and all
3 communications between the provider regarding the same, including but not limited
4 to any sonogram and related records provided by Petitioner.

- 6 4. The name and contact information of the tele-health doctor Petitioner spoke with
7 on the day of the miscarriage and all communications with the provider regarding
8 the same, including the image(s) of the two (2) stillbirth fetuses with the date clearly
9 shown that Petitioner alleges she provided.

- 11 5. The text messages between Petitioner and Sarah Navarro the day of the miscarriage
12 where Petitioner sent the image of the fetuses with all pertinent meta data.
13

14 **IT IS FURTHER ORDERED** that Petitioner must provide the above information no
15 later than 5:00 p.m. on April 19th, 2024.

16 **IT IS FURTHER ORDERED** the request for attorney fees and costs will be joined
17 with previous requests to be heard at the trial/evidentiary hearing on June 10, 2024.
